c4c Vision

Better medicines for babies, children and young people through a pan-European clinical trial network

Mission

c4c will use a coordinated approach to deliver high quality “regulatory grade” clinical trials in:

- Multiple countries
- Multiple sites
- All pediatric age groups

How to do it

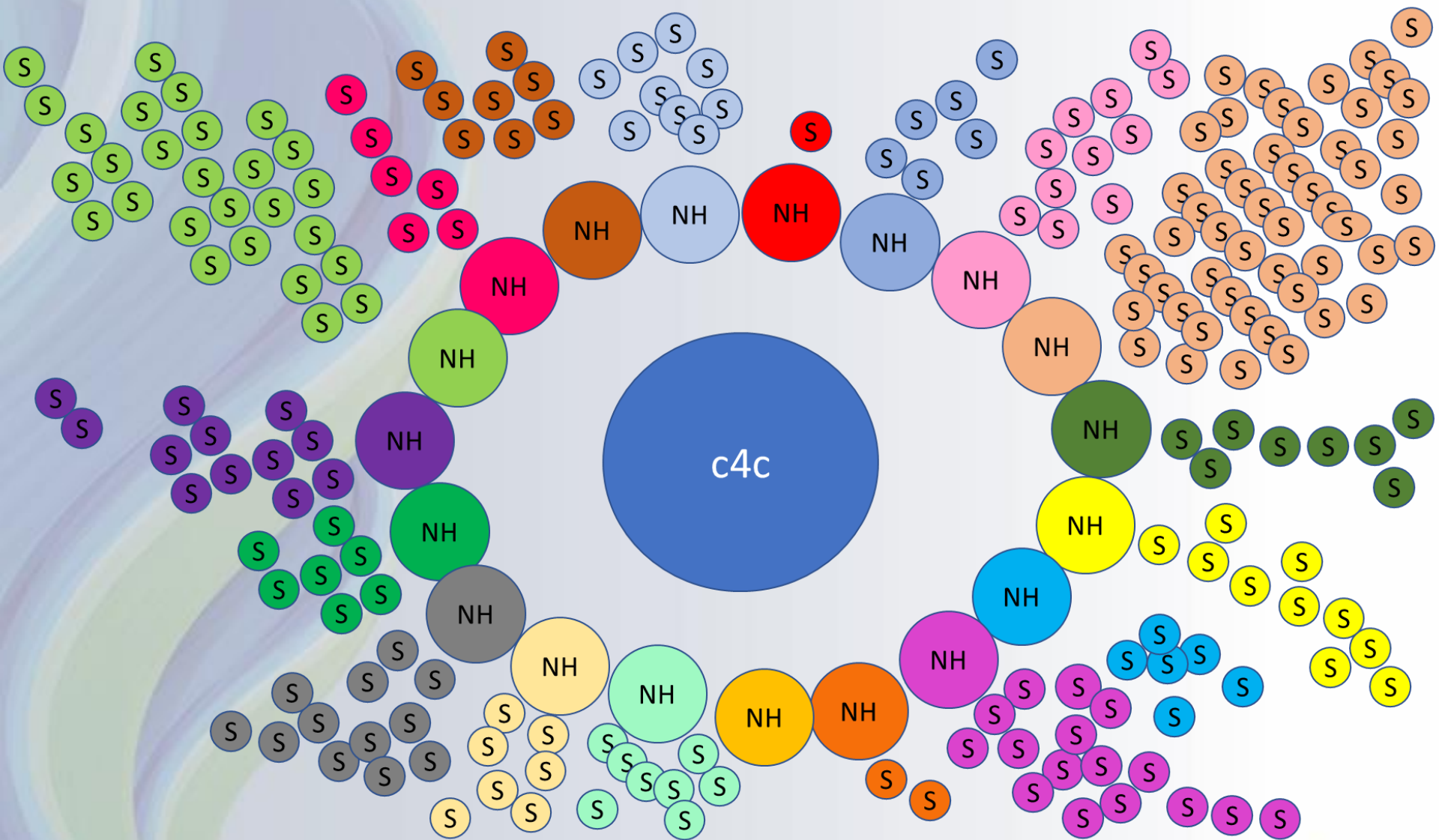
- Build a large infrastructure with 19 National Hubs (NHs) and over 200 sites in their National Networks
- NHs
 - are the national contact points of c4c central organisation
 - gather participating sites in each country
 - connect National Networks (NNs) to c4c

National Networks

- NNs have variable functional history
 - 50% of NNs have been established during 2017 or after
 - 50% of NNs have functional history of more than 3 years
- Experience, operations, legal structure and funding vary across countries
- Some networks are big and some are small, some are expanding (finding new sites in their country)

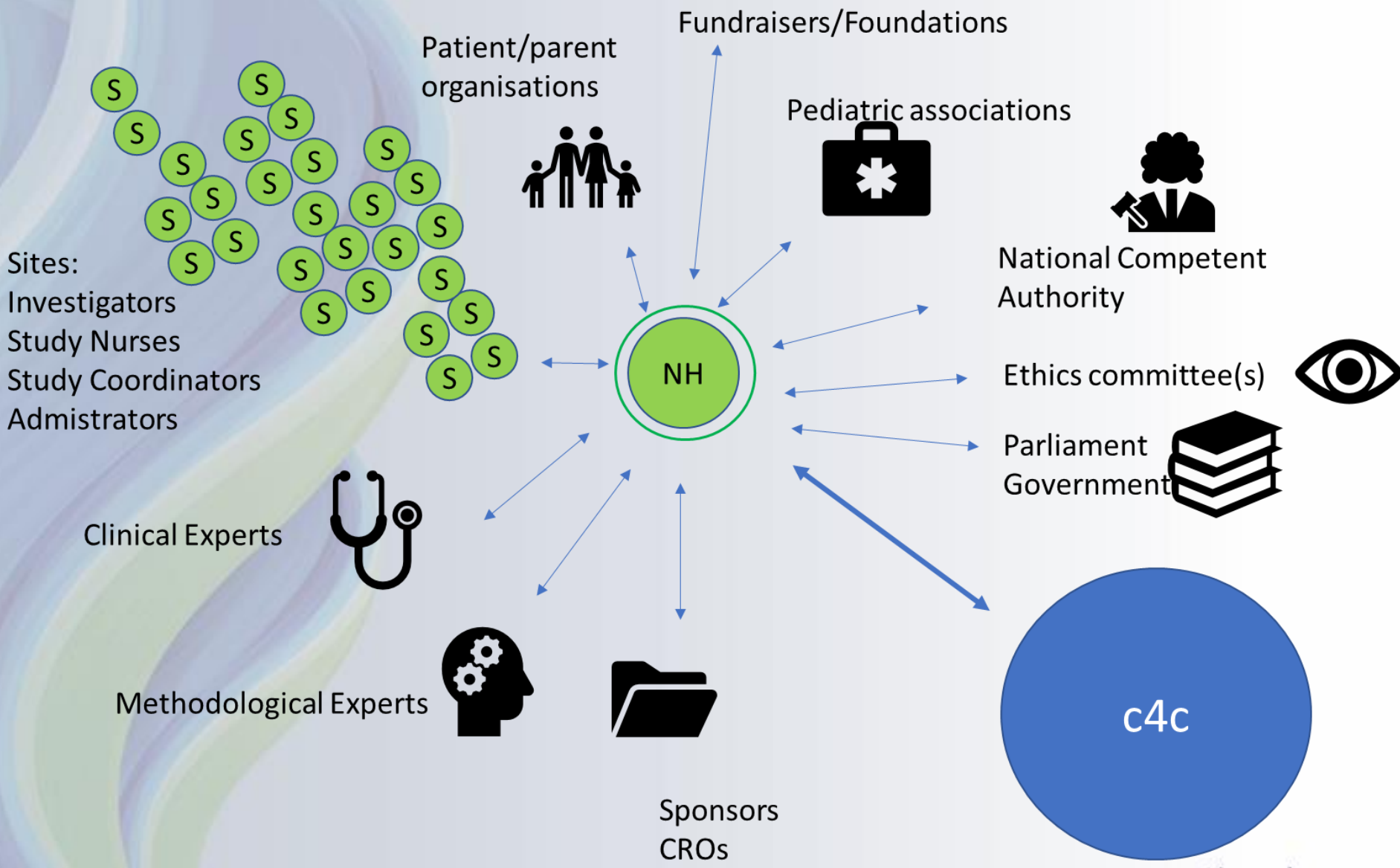

National Hubs in c4c

- Bring together stakeholders in the country;
 - Sites, pediatric associations, regulators etc.
- Share information and expectations in c4c with sites
 - Support and mentor sites
- Pilot and implement c4c systems and documents, e.g. contracts, agreements and SOPs
- Fulfil requirements of tasks in c4c with named responsibility
 - Contribute to consultations about other tasks



National Hubs in c4c: harmonized operations in the country

- National Agreements (as much as possible)
- Preparation of sites uniformly for network operations
 - Training
 - Experience sharing
 - Qualification of sites
- Send concordant information about trials to sites
- Gather information from sites about feasibility, budgeting etc.
- Manage expectations about time, quality and scope of c4c

National Hubs in c4c; monitoring of network function in the country

Contribution to collection of information to data systems:

- Site performance
 - Ensure sites supply metrics data
 - Promote good metrics for trial performance
- Hub performance
 - Supply hub metrics data
 - Deliver good metrics for hub performance

Summarise national performance

- Contribution to sustainability of national hub and c4c
